This structure ensures our incentives are aligned with the public good and long-term trust.

2. Market Opportunity

The UK building sector comprises:

The combined value of this market exceeds **£80 billion annually**, making it one of the most economically vital, and vulnerable, industries in the country.

Yet despite its size, it remains underserved by modern verification, data analytics, and public accountability tools.

3. The BuilderWatch Solution

BuilderWatch has invested substantial time, expertise, and resources into developing a piece of bespoke software that has allowed the creation of the Builderwatch platform with advanced functionality that:

- Provides tailored legal and planning advice by postcode and house number.
- Trained on **LPA planning policies, enforcement data, and building regulations**.

- Opens up future expansion into monetised builder referrals, legal consultations, and compliance services.
